Conduct Committee Actions Review

Update on Conduct Committee Formation

Call for members went out, and we collected responses. Had a BARCC training in August with 8 or 9 participants. Second set of training focusing on investigation and confidentiality is being scheduled.

Review and Select Conduct Committee Members

All applicants (15) seem to be acceptable candidates. All people who have attended the first training can continue through the process, and we will inform that that if they attend the second training that they will be approved for the conduct committee.

Security Post-Mortem

Hired security isn't able to do a whole lot of stuff, and when we had incidents they did the those limited things that they could do. Was this worth the cost? Do we get benefits in terms of insurance or liability? The main value seems to be in the case of a violent altercation, which is not an event we have had occur yet.

Other topics to consider for next year:

- What steps can we take to prevent an ejected participant from returning? (Ask a lawyer, State Police, is there value in a restraining order, etc)
- Do we need better control on wristbands given the limited number of gate volunteers on shift at any given time?
- Do we need, and can we manage, greater perimeter security?

Board Members, Core Liaisons and Core Leads for 2015

We could use more board members to replace departing members, handle officer roles, and acting as core liaisons. We have had some unsolicited expressions of interest, but we should put together some sort of public message soliciting interest. [Action: Draft a call for board members --Forest, Sadiya]
