#### **Bug Burn Medical Incident**

- Insurance: we've taken care of all the notification stuff, nothing more to do at this point
- Press: Kirk said local paper may be in touch, they haven't been yet
- Connecting "care" volunteers
- Volunteer debrief and facilitated Incident review? Pete
  - Nick Colangelo suggested tool
  - Suggestions for facilitators have been made
  - Need to take care to have a structured discussion; the actual incident review should be for people with named roles in the incident response
  - Output can be suggestions for process changes
- Next steps for the community?
  - Anything we do should first be reviewed by the affected participants
  - Funeral was yesterday; going to give them a few days before asking any questions
  - Carly to take the lead on organizing some sort of community event

### August 20 meeting with Kirk

Gordon has done about \$10k of additional repairs on Kirk's land. Some of this is questionable on who should be responsible – us or landowner? Much of the weather-related damage is independent of our usage of the land. We should pay – we would have done this had the damage occurred the week before firefly – but this is a follow-up item for the meeting with landowner.

#### Frank - Rental Concerns

#### 1 - Parking

Trying to hunt down the identity of some cars. On Saturday the offsite lot was closed for road repairs. Some people took down the barrier rather than waiting for Gordon to finish. Parking said these people were very rude to them as well.

[participant] and [participant] were two identified; spoke with them. Got impatient and decided to take matters into their own hands, and indicated to others they could do this too.

This is wrong, especially for people who know better and are Rangers, and we should figure out what to do about it.

Some of the other people directed by them drove around the back and may have driven over the septic field which could have resulted in damage. (One has identified themselves.) If there is any damage, would like to send the bill to the people who drove around the back. Have only identified one of them.

Request: make/model/plate data in vehicle pass database so we can identify later.

We consider this an official report to the Board on violation of code of conduct.

#### 2 - Medical Staff Rental

This team was far better, but were communication issues. They showed up and thought they had the whole house, which was not what was agreed. Friend had been staying and had to act as house manager as they kept breaking the guidelines of the rental – tracking mud through the house, party in the living room, etc. Would like to give her a discount on her rent, had to hire a cleaner to account for the usage. Friend owes \$, cleaner was \$. Moving these topics to email.
