Event Planning

- Portos
 - Walkthrough with porto vendor went well, they think they can do it, they have backup plans, "they seemed very confident" they liked the new road
 - Locations
 - Bank of 8 portos between Howl and Diode
 - Bank around Potato Support
 - Entrance to woods (inside the woods not right next to the well)
 - Others in the middle of things
 - Placement definitely knows, camps that are normally there also notified
 - Original places- 2 at lower parking, some at upper
 - O How often serviced?
 - Every day, Wed/Thu morn, 2x Fri and Sat. Normal schedule
 - 7-8am, so pretty early for most people
 - Minor concern about overflow of the handwashing station towards the stream?
 We'll see if it happens & deal then
 - Maybe communicate that vendors will be in the woods in case people are worried about nudity etc
 - A lot of ads in the portos, we might lose the \$300 damage waiver if defaced maybe who knows
- Work weekend 1 went well, good turnout
- Ticketing going well
 - 199 on waitlist now, everyone on original lottery has gotten offer by now
 - Expect probably 150-180 more refunds based on prev years
- Landowner Liaison
 - Someone probably check in with Kirk in case there are any problems
 - We should kick off the Friends and Family tickets for Kirk (has not started yet)
- Sanctuary
 - Set up accounts for 2 new people presumably new leads

 - Concomm by policy should tell reporters before interviewing [participant] so this should happen in the next week?

Rangers Meeting

- They say "that's a good idea" but haven't scheduled specific times yet, poll on Monday/two days ago but no replies
 - Also still missing budget
 - Jered Floyd will text Q directly about the budget and also the meeting. Also will tell Stever to tell Aster to get back on the ticketing waitlist
- We aren't worried at all about people signing up for shifts or Rangers happening at the event, so failure mode of this not happening seems low
- We'd like to review any official ranger policies/procedures, maybe stuff from S3 since none of us were there Can this/Do we want this to happen before the event?
 - Jered to include this when bumping the meeting with safety leads
- Might be helpful to brainstorm topics of discussion before this meeting

Apogaea

- "Volunteer notified ICS, got escalated to county police"
- Let's not catastrophize and not call the cops unless it's an actual emergency

Finance Committee

- Finance pretty much waiting for the postmortem to figure out actual spend vs. budget
- Tristan has investigated some other burns' public finance info to figure out their costs, unclear on how we could really cost less without actively cutting back on stuff we provide
 - The other burn I looked at had way way lower security, DPW, gear rental costs
 - Biggest line items are contracts that we don't have that much control over: security, EMS, gear rental, land
- May run into a PWYC cap at some point
- Possible survey question: "how much of a stretch was it to pay for your firefly ticket?"
- Let's talk more after the event
- Also let's finally dump Citizens bank
- Tristan to follow up with Kelli
 - Received a notice of extension for 2024 so nothing accruing on that at least
- Ticketing has asked if we need to collect sales tax in VT. Unclear?? finance will investigate after the event
 - Ask Kelli / a tax professional in VT
- Could we consider other fundraising events? Think about this after the event.
